

**First by-law amending the study and examination regulations
for the
Bachelor's degree programme
Building Products and Processes
at
Deggendorf Institute of Technology
of 22 February 2023**


Based on Art. 9, 80(1), 84(2) Clause 1 of the Bavarian Higher Education Innovation Act (BayHIG) of 5 August 2022 (German law and ordinance gazette (GVBl.) p. 414, BayRS 2210-1-3WK), last amended by Section 3 of the Act of 23 December 2022 (GVBl. p. 709), Deggendorf Institute of Technology enacts the following by-laws:

Section 1 Amendments

The study and examination regulations for the bachelor's degree programme Building Products and Processes dated 01 October 2022 are amended - as follows:

1. In Section 2, paragraph 2 shall be deleted without replacement. The previous paragraph 3 shall become paragraph 2.
2. Section 3 sentence 2 and sentence 3 shall henceforth read:
²The degree programme is taught in English.³ Students must demonstrate language proficiency in English at the B2 level according to the European Framework of Reference for Languages at the time of application.
3. Section 4(4) shall henceforth read:
(4) Modules may also be taught in blocks.
4. The annex *Übersicht Building Products and Processes (BPP) / Bauprodukte und -prozesse* (Overview Building Products and Processes (BPP)) is deleted without replacement.

5. The *Anlage zur Studien- und Prüfungsordnung für den Bachelor-Studiengang Building Products and Processes / Bauprodukte und -prozesse an der Technischen Hochschule Deggendorf* (annex to the study and examination regulations for the bachelor's degree programme Building Products and Processes / at Deggendorf Institute of Technology) is amended as follows:
